**Completion Guide:** 

- Your full legal name as it appears on your official documents (driver's license or birth certificate) is required.
- IRS regulations require colleges to provide accurate SSN's. If no SSN is provided to MCC, a Student Taxpayer's ID form is required and will be sent to you for completion.
- Student signature is required and serves as confirmation that the information provided is true.
- Parent/guardian signature is required if the student is under 18 years of age. Students under the age of 18 will not be allowed to register without a parent/guardian signature.
