The Sarpy County Election Commission is conducting a special election for Sarpy County School District 0001 (Bellevue Public Schools). This is an election by mail; therefore, no polling places will be open on Election Day. The date of the election is Tuesday, September 13, 2016. The deadline for receipt of the voted ballot in the Sarpy County Election Commissioner's office is Tuesday, September 13, 2016 at 5:00 p.m.

INSTRUCTIONS TO VOTER

Please follow these instructions precisely, otherwise, your ballot may not be counted.

1. Verify that there are initials of an election official at the bottom of the ballot.
2. Verify that there are no voting marks on the ballot.
3. Use a pencil or black or blue ink pen to mark the ballot.
4. Fill in the oval completely (●) next to either "FOR said bonds and tax" or "AGAINST said bonds and tax".
5. Do not cross out or erase. If you make a mistake, write "VOID" across the face of the ballot and call the Sarpy County Election Commissioner for instructions, 402-593-2167.
6. After voting, insert the ballot into the Return Identification Envelope. **SIGN** and seal the Return Identification Envelope. Your ballot will not be counted if your signature is not on the back of the return envelope. Do not place more than one ballot in the Return Identification Envelope.
7. Any voter physically unable to sign the envelope must make his/her "mark" and have a witness print the voter's name and then the witness signs their name below the signature line.
8. Place postage on the envelope if returning by mail.
9. Mail or deliver your ballot to the Sarpy County Election Commission, 501 Olson Dr. Ste. 4, Papillion, NE 68046. Your ballot must be in the possession of the Sarpy County Election Commission by September 13, 2016 at 5:00 p.m.
10. For your convenience there is a Ballot Drop Box available 24 hours a day in front of the Election Office.

"Shall Sarpy County School District 0001 (Bellevue Public Schools) in the State of Nebraska (the "District") issue its bonds in a principal amount not to exceed Seventy-Six Million Dollars (\$76,000,000) for the purpose of financing the costs of: renovating, rehabilitating and improving the District's existing facilities, including but not limited to, safety and security upgrades and modifications, roof repairs and replacements, plumbing, electrical, heating, ventilation, air conditioning and other infrastructure improvements, technology upgrades and improvements, environmental abatement, athletic and performing arts facilities improvements and media center/computer lab upgrades, modernizations and conversions; acquisition and/or construction of real property and/or facilities for District use; constructing one or more additions to and related site improvements for such facilities and additions; and acquiring necessary furniture, equipment and apparatus for such facilities and additions and other use by the District; and

"Shall the District cause to be levied and collected annually a special levy of taxes against all the taxable property in the District sufficient in rate and amount to pay the principal of, the premium, if any, and the interest on said bonds as the same become due?"

FOR said bonds and tax

Electors voting in favor of said proposition shall blacken completely the oval opposite the words "FOR said bonds and tax" following said proposition, and electors voting against said proposition shall blacken completely the oval opposite the words "AGAINST said bonds and tax" following said proposition.
